- 2. Motion is made by Tim, seconded by Diane, and unanimously approved by the Board to approve the Board meeting agenda.
- 3. Motion is made by Diane, seconded by Tim, and unanimously approved by the Board to approve the November Meeting minutes.
- 4. Neighborhood Engagement
  - a. Jeremiah and Joe from BKV provide an update on Duffey redevelopment
    - 1. General overview provided to the board no major changes since presentation in July to P+Z board
    - 2. Heritage Preservation Commission granted a Certificate of Appropriateness and approved signage
    - 3. Pending additional approvals, construction expected to begin in spring/summer 2020

  - 1. Duffey Redevelopment
    - 1. Had to cancel presentation
  - 2. 270 Hennepin Ave Tower
    - Outside of North Loop neighborhood, but wanted to request a letter of support to modify construction plans (outlined in December 2019 P+Z meeting notes)
    - Letter of support provided by P+Z committee to accommodate a tight deadline by developer with clear statement it was not approved by the NLNA board as a whole
    - 3. No board vote because City of Minneapolis already approved the modification
  - 3. Trash can specifications
    - 1. P+Z would like the specifications to provide to developers Tim will provide
- c. Community Engagement Scott Woller
  - 1. North Loop community garden
    - 1. Forms need to be submitted to the city to move forward provided to Tim
    - 2. Annual Meeting
      - 1. Tim has volunteer registration, meeting registration, meeting agendas, ballots printed
      - 2. 10 additional volunteers needed board members have identified individuals who can assist
      - 3. An overview of events was provided
      - 4. A process to determine a winner for the board elections in case of tie may be necessary due to the high number of candidates
    - 3. Volunteer gifts
      - 1. Previous discussion about obtaining t-shirts for people that volunteer for community events not cost sustainable at this
      - 2. Scott proposes a stainless-steel mug or some alternative
